FOR THE STUDENT WORKER:

In exchange for the privilege of riding on one or more of Sunnybrook Farm's horses, and/or receiving lessons from a trainer at Sunnybrook Farm, I agree to the following:

- I will complete **all** tasks on my assigned "Barn Duties Checklist" before I may be allowed to ride or participate in other activities.
- I will complete **all** tasks as written on the checklist and/or instructed verbally.
- I understand that the horses and other animals are living creatures, and my failure to complete all of my tasks correctly and in a timely manner could cause a horse to become injured or sick.
- I will not sign the log sheet until I've completed **all** tasks on my assigned "Barn Duties Checklist."
- I understand that completing all of the tasks on my assigned checklist may take between **1.5 and 3 hours**.
- I will read, listen, and follow all rules and directions posted and spoken aloud.
- If I do not understand how to complete a task, I will ask for direction.
- I will be present on the days I've signed up for, at the time I've signed up for.
- If I cannot be present when scheduled, I will make timely arrangements for someone else to complete my assigned tasks.

FOR THE PARENT/GUARDIAN:

By signing below, I agree that I have read the student responsibilities above, and affirm that I have read and agree to the following:

- Student worker tasks are divided into a number of "Barn Duties Checklists." Each checklist should take between 1.5 and 3 hours to complete. Each checklist is simple enough to be completed by one person, and the tasks have been divided as fairly as is possible.
- Your son/daughter will be expected to complete all tasks as assigned before they will be permitted to ride or take part in other activities on the day(s) they have selected to work, unless they have previously scheduled paid lessons on one or more of those days.
- Sunnybrook Farm is a working equine facility, and as such there are many dangers, both obvious and non-obvious. All participants and guests must be aware of their surroundings at all times. No one should complete a task they do not understand.
- Your son/daughter is expected to act in a mature manner at all times. Goofing off and breaking the rules will not be tolerated.
- One hour of work is equivalent to 10 minutes of ride/instruction time. Your son/daughter must accrue at least 15 minutes of ride time before they may use their accumulated time.
- No ride/instruction time will be accrued for tasks done incorrectly or partially.
- Sunnybrook Farm is not a daycare facility*, and should not be treated as such. You should only drop your son/daughter off at their scheduled time, and they must be picked up when their work and/or ride time is completed unless otherwise arranged in advance.
